COSFDA Labor Standards Training

This training is intended to help HUD grantees understand the requirements of Federal labor standards regulations on HUD funded construction projects. This training is designed to assist state program staff with a deeper knowledge of Davis Bacon and Related Acts and the state's role in reviewing and monitoring federal labor requirements.

COSFDA Fair Housing and Equal Opportunity Training (including 24 CFR Part 75)

This training expands on the material covered in CDBG Boot Camp of the requirements for states to meet fair housing and equal opportunity requirements for their HUD funded programs. The training includes information on the new Section 3 rule (24 CFR Part 75), Affirmatively Furthering Fair Housing and other civil rights and equal opportunity requirements.
