Thank you for your long-established leadership in supporting the Community Development Block Grant (CDBG) Program. The undersigned members of the CDBG Coalition urge you to support no less than \$4.2 billion for the program in FY26. With inflation and stagnant CDBG allocations, the program is not able to fully meet existing needs. Local grantees report receiving more CDBG funding requests than they can accommodate. Further, the cost of labor and materials related to the program's two major activities, infrastructure and housing rehabilitation, has increased exponentially. And, with rising inflation and housing costs, more people need assistance.

While we are seeking \$4.2 billion in FY26, the current authorized funding level for CDBG, we urge you to support no less than the \$3.3 billion approved by the House and Senate THUD subcommittees in a final FY25 spending measure.

CDBG strengthens communities. Rural, urban, and suburban areas all receive CDBG funds. It is an essential resource for helping communities tackle serious challenges such as preserving owner-occupied single-family housing, installing and improving critical infrastructure such as water and sanitation systems, providing critical life-saving improvements such as fire equipment in rural areas, funding food banks, and providing homelessness prevention services, to name a few important activities addressed by CDBG. *There is no other federal program that provides communities with the resources to collectively address these issues.*

One of the program's greatest strengths is its ability to leverage other investments. As a flexible resource, CDBG often serves to match other sources of public and private funds. It also helps projects and services become reality by providing gap funding to meet budget needs. The CDBG program demonstrates a high return on investment for taxpayer dollars. Every \$1.00 in CDBG investment leads to \$5.02 from other public and private sources.<sup>1</sup>

As you consider FY25 and FY26 funding for programs under your jurisdiction, we urge you to support our requests for the CDBG program – a program that helps states and jurisdictions and their program partners address serious challenges to health, safety, and livability.
