#### **COSCDA Environmental Review Training**

This training is intended to help HUD grantees understand and fulfill environmental review requirements of their programs. This training is designed to assist state program staff with a deeper knowledge of Part 58 environmental review requirements and their role in reviewing and monitoring ERR's.

## **COSCDA Acquisition and Relocation Training**

Wednesday, November 19, 2025

12:30 pm - 4:00 pm EDT

Fee: \$295.00 (COSCDA Member) and \$395 (non-COSCDA Member)

This training expands on the material covered in CDBG Boot Camp to provide a high-level review of the requirements of the URA. Attendees will engage in exercises and group discussions on the topic and be provided with useful tools and resources that will better equip state staff to manage HUD funded projects that involve acquisition of real property, residential relocation, and non-residential relocation.

## **COSCDA Labor Standards Training**

Thursday, November 20, 2025 12:30 pm – 4:00 pm EDT

Fee: \$295.00 (COSCDA Member) and \$395 (non-COSCDA Member)

This training is intended to help HUD grantees understand the requirements of federal labor standards regulations on HUD funded construction projects. This training is designed to assist state program staff with a deeper knowledge of Davis Bacon and Related Acts and the states' role in reviewing and monitoring federal labor requirements.

## **Registration Fee (COSCDA Member and Non-Member)**

The cost per individual training module is \$295 (COSCDA member) and \$395 (non-COSCDA member) per person. Members who register for all three training modules will receive a **15%** discount.
