Dear Chair Cole and Ranking Member DeLauro:

On behalf of 105 nonprofit, public, and community-based national organizations serving communities in every state, we write you to urge Congress **stop** the U.S. Office of Management and Budget (OMB) or any implementing agency from implementing its proposed revisions to the Uniform Guidance, or any substantially similar policy. This starts *but does not end with* passing the Senate-passed continuing resolution pausing implementation until after December 11.

OMB's proposal represents a sweeping and complex overhaul of federal grantmaking that raises serious concerns. As drafted, the rule would inject substantial uncertainty into federal funding by allowing agencies to withhold, suspend, or terminate grants, as well as change key terms and conditions, including mid-performance. As such, this proposal would expose grantees to significant financial, legal, and operational risks, making it harder to deliver essential services in communities.

The consequences would extend across the country. Every state, local government, nonprofit and federal grant recipient or state and local subgrant recipient, could be harmed by OMB's proposed rule. The reach and impact would be extraordinary and extremely harmful as grant recipients and downstream contracts and community organizations rely on predictable federal funding to carry out critical functions, from housing and infrastructure to health care, education, disaster response, sustainable food production, and community services. This result would be chaos or stagnation in the project. Projects simply will not be finished in a timely manner if they are completed at all—which would fly in the face of Congressional intent funding these programs.

Independent analysts, including Moody's Ratings¹, have warned that the proposal could weaken the reliability of federal funding commitments and negatively affect credit ratings

for state and local governments, increasing borrowing costs and ultimately raising costs for taxpayers. This coupled with the inflationary pressures, slowing economic growth and a desire by Congress to limit domestic discretionary spending impact all Americans.

Two examples of the impact:

- Affordable housing projects already rely on fragile capital stacks that layer HOME and CDBG grants, LIHTC equity, subordinate loans, and philanthropic dollars to close gaps created by below-market rents. When a federal grant in that stack can be terminated mid-stream based on shifting priorities, developers must either rely on more expensive private debt or walk away from deals, leaving sites undeveloped, increasing local housing shortages, and families struggling to access affordable housing.
- Colleges and universities have already seen what happens when federal disease-research grants are cut or delayed: labs closed, graduate and post-doctoral researchers lose jobs, and promising projects on cancer, infectious disease, and chronic illness stall. Thousands fewer federal research grants awarded to institutions in 2025 compared with the prior five-year average. Unpredictable federal support pushes universities to chase short-term, low-risk projects instead of long-horizon studies needed to understand and prevent disease, undermining the very “Gold Standard Science” the proposed rule purports to prioritize.

Given the breadth and significance of these concerns, we urge Congress to act to prevent implementation of this rule or any similar policy.

To the U.S. Office of Management and Budget:

Re: OMB-2026-0034, Office of Management and Budget (OMB) Regulation for Federal Financial Assistance

We, the undersigned 1,930 organizations, oppose the U.S. Office of Management and Budget's (OMB) proposed changes to overhaul the set of rules, known as the Uniform Guidance, governing federal grants, cooperative agreements, and other monetary awards to nonprofits, state and local governments, and other grantees.

If implemented, the OMB proposal would create significant financial risk and instability for federal grantees, making it more difficult to provide vital services to communities. If implemented, grantees will be faced with unpredictable financial, legal, and reputational risks that increase the costs of accepting federal awards while decreasing the benefits. Many effective and qualified grantees may be unable to accept those risks. This could lead to disruptions to essential services, including housing, community development, health, education, food, shelter, community services, disaster recovery, and more in communities and states nationwide.

The proposal allows federal agencies to determine discretionary federal awards based on partisan ideology, not community needs or congressional intent. OMB proposes to create a pre-approval process that allows political appointees to exclude grant proposals from consideration if the proposal is not consistent with "federal agency priorities and the national interest." Grantees would not know whether and why their proposal was rejected through this process, and they would be unable to challenge such actions. Moreover, the proposal directs agencies to consider a grantee's membership or affiliation with other organizations that "undermine public safety or national security" and grantees' engagement in "activities or initiatives that are inconsistent with federal civil rights laws." These provisions could exclude grantees that work to advance racial equity or grantees that oppose an administration's policies. Taken together, these provisions would essentially allow any administration to disqualify a grantee it disfavors.

The proposal would force grantees to operate in a shifting environment, increasing the difficulty of administering federal programs. The proposal directs agencies to align federal programs with "administration policies and priorities," creating uncertainty as each new

administration could make significant, substantive changes. OMB proposes to allow federal agencies to terminate or suspend discretionary grants without cause and to change grant terms and conditions mid-performance. Federal agencies would be authorized to impose onerous oversight and monitoring requirements across entire programs, regardless of the grantee's individual performance. When a grant is terminated under the agency's discretion, the agency would not have to provide grantees with any administrative hearing or appeals process. Federal agencies could withhold federal discretionary grants indefinitely, if the agency determines that the grant does not "advance the president's policy priorities." Moreover, under the proposal, agencies could terminate grants if subrecipients "damage the reputation" of the federal government, a term that is not defined.

The proposal threatens important congressionally funded federal programs that help address longstanding racial, social, or other disparities or serve underserved communities.

The proposal purports to bar any federal funding from being used to promote "unlawful" diversity, equity, and inclusion (DEI) efforts or illegal immigration. However, many DEI-related practices and policies that the administration claims are unlawful have been upheld by courts as permissible under the law or can be administered lawfully. Grantees lawfully provide immigration legal services, humanitarian assistance to asylum seekers, or emergency shelter to migrants. Those most impacted are people of color and their communities, which have experienced historic and ongoing federal disinvestment.

We urge you to reverse course and stop these proposed changes.
